Sub: - The Service Tax Voluntary Compliance Encouragement Scheme (VCES) - Notifying of designated authorities - regarding.

Attention of the field formations, service providers, trade & industries, the public in general and all concerned is invited that the Service Tax Voluntary Compliance Encouragement Scheme, 2013 (VCES) has come into effect upon enactment of the Finance Bill, 2013 on 10th May, 2013. The Notification No.10/2013-S.Tax dated 13.5.2013 has also been issued under the authority of sub-sections (1) & (2) of Section 114 of the Finance Act, 2013 (17 of 2013) for making "Service Tax Voluntary Compliance Encouragement Rules, 2013" for carrying out the provisions of VCES regarding the form and manner of declaration, form and manner of acknowledgement of declaration, manner of payment of Tax dues and form and manner of issuing acknowledgement of discharge of Tax dues. The provisions and procedures governing the aforesaid scheme are provided in the Service Tax Voluntary Compliance Encouragement Scheme, 2013 {under Chapter VI of the Finance Act, 2013 (17 of 2013)} and the Service Tax Voluntary Compliance Encouragement Rules, 2013, which may be referred to.

2. In exercise of the powers conferred by Section 105 (1) (c) of Chapter VI of the Finance Act, 2013 (17 of 2013), the following Central Excise Officers are notified as "Designated Authorities" for the Service Tax Voluntary Compliance Encouragement Scheme, 2013 for the jurisdiction of Commissioner of Central Excise, Customs and Service Tax, Bhopal:-
